Virtual Stock Exchange (VSE)	Students will build and manage a simulated portfolio throughout the course (starting fourth week of the course). VSE can be utilized via a web browser. To encourage you to put effort into the simulation, we will do the following. The student with the maximum portfolio value on (23th week of the course-by close of trading day) will get the equivalent of a 95 on the Final Exam (thereby likely exempting the student from the Final Exam with an A Grade). Any student who underperforms the S&P 500 by more than 10% (e.g. S&P is up 5% and you are down more than 5%) will have 5 points subtracted from their Final Exam Score (e.g. 75 score on Final Exam is adjusted downward to 70). Conversely, any student who outperforms the S&P 500 by 10% will get 5 points added to their Final Exam score. Risk Management	This course introduces the student to corporate risk management. We survey the current practices corporations use in protecting their assets from random events. You will learn of the tools firms use to measure, estimate, and mitigate a variety of risk exposures, by insurance, hedging, and diversification. Covered risk exposures include interest rate risk, fx risk, credit risk, market risk, liquidity risk and operational risk. In light of current financial markets crisis, the course will focus on risk exposures associated with financial intermediation.
